- When we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- With our trusted services providers who work on our behalf, but do not have an Independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.
- To third party analytics companies

Compliance with children's online privacy protection act

Protecting the privacy of the very young is especially important. For that reason we never collect or maintain information at our Site from those we actually know are under 13. The Services are not designed nor intended for use by children or anyone else under the age of 13.

Changes to this privacy policy

"Processing," means using cookies on a computer/hand held device or using or touching information in any way, including, but not limited to, collecting, storing, deleting, using, combining and disclosing information, all of which activities will take place in Australia. If you reside outside Australia your information will be transferred to Australia, and processed and stored there under Australian privacy standards.

By using the Application and providing information to us, you consent to such transfer to, and processing in, Australia.

If you do not agree to this policy, please do not use our Site. Your continued use of the Site following the posting of changes to this policy will be deemed your acceptance of those changes.
